

MINUTES OF THE MEETING OF SOUTH WONSTON PARISH COUNCIL Held on Monday 11th April 2022 at 7.30PM To be held at the Pavilion

Present: Chairman Perrins, Cllr's Peal, Street, Oram and Berry, City Councillor Horrill, County, City Councillor Godfrey, Lt Col Stu Allen and Clerk Mrs R. Jones.

22/001 APOLOGIES FOR ABSENCE

Apologies were received from Vice Chairman Selby, County Cllr Warwick & Clerk Mrs R. Jones

22/002 DECLARATION OF INTERESTS

No interests to be declared.

The Chairman suspended Standing Orders.

22/003 PUBLIC PARTICIPATION

The Chairman allocated forty five minutes for Public Participation in relation to item 8 (Winchester City Council Local Plan Update) which was brought forward for discussing the Local Plan and housing allocation.

Residents had a number of questions for the Parish Council:-

- They had read the draft response from WCC and asked if that sort of response would influence Winchester City Council (WCC) decision and if things like access to plot 02 could be pushed more to be more concrete? Cllr Perrins said that this was just a first draft which wouldn't go anywhere, and a second draft report is being written. A decision will be made this Thursday about an extension to the response deadline;
- 2. If data could still be sent into the Parish Council referring to an archaeological feature near their property? Yes
- 3. Referred to plot 01, 50-60 houses being built in an area big enough for 183; would there be further development? Jobs at the polo

school would be lost as well as views over the landscape. The strip on the south side retained by the land owner may make a path for the village;

- 4. Had seen bats going up the hedgerows and thought development would affect wildlife and also feared light pollution;
- 5. Referred to plot 07 and asked how the Parish Council are keeping residents informed and if they would get a change to comment before the final draft is sent in? Cllr Perrins had received communications at the Parish Assembly and the Parish Council was looking at the possibility of further meetings and would like an extension to the deadline of end of April. She advised residents to get writing and build up a good picture to go to WCC;
- Referred to plot 01 and supported the points made by the previous speaker and said that residents should know what was going on and options were represented. Cllr Perrins said a sound view would be sent to WCC and everyone wants what's best for South Wonston;
- Noted 2-3 dormice and many hedgehogs and asked if there was always a demand for 50-60 houses and added that development was not sustainable in terms of road access. Cllr Perrins noted that the figure had been 150 and that developers had not been successful in the past;
- 8. Referred to 05 as a brownfield site which WCC favoured (brownfield sites in general). The rest of the village thought this site would have minimal impact on South Wonston. There was also access to other schools. Had the Parish Council been told anything about the Persimmon field? Cllr Perrins said no;
- 9. Noted that the primary school is full and it was difficult already to get appointments at the Gratton Surgery. Cllr Perrins noted the pressure on Worthy Down;
- 10. Noted no mention had been made in the response about sewage and water. Cllr Perrins replied that the next draft would cover this;
- 11. They supported the National Planning Policy Framework about the use of brownfield sites and not green. If plot 05 is not preferred other sites should be looked for. The new Environment Act 2021 would offer more useful policies;
- 12. A new resident in Wrights Close noted slow worms and lizards and also low water pressure. Global warming would increase the need for water and a new system would be needed for the village. Cllr Perrins said that the merits and the difficulties of the each site should be discussed and the infrastructure looked at;
- 13. A resident asked if all the sites could be rejected. Cllrs Perrins said yes but 05, the brownfield site might be approved;
- 14. A resident asked if a school could be built at Sutton Scotney?;
- 15. A resident observed that these issues could be very emotional but due process should be followed and people informed;
- 16. Noted that Cllr Perrins would be meeting other Parish Councils on Tuesday 12th April. Cllr Perrins confirmed that this would be an information sharing meeting and would communicate back to residents;

- 17. Asked if all the Parish Councils would ask for extensions? Cllr Perrins was unsure at this stage;
- 18. A resident said it was really good to see so many people at the meeting with good skills and abilities;
- 19. Aside from the planning issues there were questions over the allocation and whether it complies with legislation. There was no link between housing and employment with South Wonston. The Parish Councils would need to share professional advice;
- 20. The resident had read the notes of the draft meeting and thought all the points were valid, saying any site that might be suitable might result in our hand being forced. Pressure on Downs Road should be reduced by putting school cars and bus onto Lower Road. Cllr Perrins confirmed this was not a vehicular access route.

A number of other residents expressed similar views that have already been mentioned above.

22/004 Reports from Local Councillors, MOD and Police

Cllr Horrill opened by saying that the SHELAA sites had been published since December 2021. The Parish Council had decided to ask for an extension as it needs a public meeting to give an appropriate response. The crucial settlement hierarchy data was incorrect and needed altering and the infrastructure was not clear and needed to be part of the response e.g. sewage. There was no data about doctors and school numbers. The Local Plan was reaching the Regulation 18 stage; the next round of formal consultation will take place during the summer whereby residents will have the opportunity to submit comments.

The Liberal Democrats support brownfield sites and expanding the number of houses, pushing out the boundary of Winchester.

It should also be noted that Parish Councils do have the opportunity to go back with more suitable sites not on the current SHELAA.

Cllr Godfrey gave a further update from Winchester City Council (WCC) which included:-

- More pony and trap racing on the A33 near Winchester. The police were asking for reports of any action. Reports should be emailed to the Hampshire Police website;
- Hampshire County Council (HCC) supported by WCC is the leading authority on Ukrainian refugees. You should approach officers at HCC if you wish to help;
- WCC supported the Greening Campaign which is running in some Parishes. South Wonston have a recycling scheme that could be expanded into other topics;
- The major consultation on the transport plan is in its last weeks; residents are encouraged to respond;

- Natural England has issued new restrictions about phosphate levels in the River Itchen around Winchester. All future planning applications which are affected by this will now need to consider the issue;
- The polling station on Thursday 5th May will be at the village hall;
- The brownfield plot 5 would be a better alternative but wanted to know why we should any development in this area. Should it be necessary to have any homes there would be a need to improve the facilities;

Lt Col Stu Allen gave an update from Worthy Down which included:-

The Queens Jubilee Celebrations being held at Worthy Down on 5th June. He would be able to offer a number of tickets to their event and was seeking a contribution from the Parish Council. Cllr Perrins said that there is a budget of £500 for Grants. It was decided to discuss this under General Amenities.

Proposal	T5 (Holm Oak by driveway)- Reduce the lateral branch extending out over garage by 2-3m back to a suitable growth point with pruning wound being no larger than 75mm diameter to allow for new growth to form as part of the crown. Reduce the overall crown by no more than 1-1.5m to suitable growth points with the longer reduction length sections focusing on the extended and protruding branches of the crown. T2 (Holm Oak within garden space) - Reduce the overall crown back to the previously approved reduction points (appeared to be approximately 2-3m reduction) to provide a balance and more uniform shape to the crown and provide separation to the property and reduce the dominance over the neighbouring gardens to north. Reduce the over extended branch growing in a south easterly direction by 2-3m to bring the branch back into line with the rest of the crown. The proposed works are to manage and maintain the two trees in close proximity to homes, allow and provide for emergency and delivery vehicle access for and a more usable garden space whilst looking to retain the visual amenity aspect of the trees.

MINUTES OF THE WCC HOUSING MEETING 24-03-2022 AT 2.00 pm PRESENT

WINCHESTER CITY COUNCIL

The meeting was opened by going over the background information. This was documented in the minutes at the March Parish Council meeting. Copies of the slides are attached.

Currently have working figures but no definites. Overall they will rely on a number of the allocations already put forward.

SHELAA: A meeting to firm up what sites are proposed. Are they likely to be subject to a sustainability study?

Cllr Perrins raised that all the sites have access issues, and also wanted to firm up what the housing numbers will be. If the SHELAA sites are not acceptable to be built on, will the boundary be expanded to build the 50 homes? It is not a Parish Council decision to expand the boundary.

There was a discussion about why the figures shown are from 2019?

What is the reason for this date? WCC couldn't answer this point

Cllr Berry asked at what stage highways, sewage and water etc will be involved in the discussions. WCC said they will be doing this during the next stage of the process.

SHELAA sites

There was a discussion about the sites being offered and the employment factors.

Cllr Godfrey asked if the parish would be able to recommend land which wasn't part of the SHELAA site. WCC said you can. Cllr Godfrey asked if an allocation site can have more than 50 homes on it, would the entire site be built on?. WCC said the numbers are currently indicative and the site does not need to be taken on in its entirety.

The Parish Council will need to feedback information to WCC by the end of April. This should include merits of the sites, or practical issues, preferred or disliked sites.

If this strategy is approved by WCC some development will happen is South Wonston.

Cllr Perrins finished by saying that it's a shame we weren't notified earlier of these plans.

Winchester City Council finished by saying that the aim of consultation with the Parish Council is to identify those sites that should be looked at by Highways and Planning instead of all sites.

Cllr Perrins said that if an extension was successful and there would be more time for open meetings we should consider setting up a Housing Working Party. The working party would be discussed again at the Public Meeting next month once an extension has been agreed.

Cllr Caroline Horrill said that WCC have visited all the SHELAA sites in South Wonston.

Councillors discussed the earlier request from Lt Col Allen about the contribution of £500 towards their Jubilee Celebrations. Cllr Perrins

reminded Council that Worthy Down are part of our parish and the Army Community Covenant had made a huge contribution to Pavilion funds.

22/013 CLIMATE CHANGE

- to receive an update from Councillors

Cllr Phil Oram met with Winchester Area SuperHomes and gave an update to Cllrs, reminding Council that this only covers homes in tax brackets A,B & C

Have you been thinking about reducing your home's carbon footprint?

Local charity Winchester Action on Climate Change (WinACC) has recently launched Winchester Area SuperHomes, a two year non-profit project aimed at reducing home energy use. It will provide homeowners with tailored, independent advice on how they can retrofit their properties to reduce their carbon emissions, and so help the City Council achieve a net zero carbon District by 2030.

WinACC is looking to provide 150 homeowners across Winchester District with detailed Whole House Retrofit Plans which cover areas such as insulation, solar panels and heat pumps. They are offering subsidies for homeowners on low and mid incomes and providing advice on available grants.

Energy use in the home is responsible for around 20% of direct carbon emissions. Winchester Area SuperHomes can help homeowners to transform the energy performance of their home to reduce its carbon footprint, by retrofitting. Retrofitting means changing a property so that it uses less energy and has lower carbon heating.

Winchester Area SuperHomes will provide help with some costs for homeowners on low and middle incomes (but is open to homeowners on all income levels) - this will include some of the survey and design costs. But the real benefit is being linked into a project that provides:

- Access to qualified and accredited Retrofit Coordinators
- Technical back up from the National Energy Foundation
- Support to access grants

The first step is for the Project Officer to arrange a home visit or video call to explain exactly how Winchester Area SuperHomes works. They will then put you in touch with a qualified Retrofit Coordinator who will carry out a survey of your property and produce a Whole House Retrofit Plan. This is a detailed assessment of your property and will include a costed list of all the measures you could take to reduce your home's energy use and carbon footprint. There are several grants available for home energy retrofit – and the Project Officer can help you apply for them. From April, the Boiler Upgrade Scheme will provide grants of £5,000 towards the cost of an air source heat pump. For homeowners on low incomes, the Green Homes Local Authority Delivery scheme can provide grants of up to £10,000.
